I hereby accept this risk and hold harmless EC, the OE, Cadora, Cadora-Ontario, the competition (Glanbrook Cadora), and the site Ancaster Fairgrounds, their officials, organizers, agents, employees and their representatives. The person responsible (PR) agrees to the release of any information on the entry form to EC."

I hereby certify that every horse listed on this entry form has met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations.

All riders, regardless of age or level or competition, must wear ASTM/SEI or BSI/BS EN approved properly fitted and fastened protective headgear at all times when mounted at the Glanbrook Dressage competition at the Ancaster Fairgrounds location. Glanbrook CADORA applies this helmet rule to all its competitions without exception.

"In the event that (**JR. name**) \_\_\_\_\_ participates in an Equestrian Canada sanctioned competition where protective headgear is required for juniors, he/she will wear properly fitted and fastened approved headgear at all times while riding or driving at the event location.
